AGENDA ITEM: Approval of the December Regular Commissioners' Meeting Minutes (December 12, 2013)

\*MOTION\* Commissioner Cassidy moved to approve the December Commissioners' Meeting Minutes. Commissioner Gardner seconded the motion which passed 2-0-1.

Commissioner Crowley abstained.

AGENDA ITEM: Monthly and Quarterly Reports

The Commissioners were provided monthly reports in their meeting packets. (See attached)

AGENDA ITEM: Payroll Status Change Notices

By consensus, the Commissioners accepted the resignation of Travis Oakes as a part-time deputy effective 12/16/13. Travis is unable to

continue working for the Sheriff's Office with his new position as a Jidicial Marshall.

Following a hiring process, Sheriff Smith recommended Timothy Carter for a Patrol Deputy position. Timothy has recently returned home from service in the U.S. Marines.

\*MOTION\* Commissioner Cassidy moved to hire Timothy Carter as a full-time Patrol Deputy effective 01/05/14. Commissioner Crowley seconded the motion which passed unanimously.

Commissioner Gardner thanked Timothy for his service to the Country.

AGENDA ITEM: Six-Month Certificate for Heron Weston.

The six-month certificate presented was signed.

AGENDA ITEM: Tax Abatement Decision

The tax abatement for James vs. Greenlaw Chopping Twp was granted.

AGENDA ITEM: Appointment of Commissioners and/or County Manager to Committees and Boards.

The Commissioners were provided with a list of committees and boards on which the Commissioners and the County Manager sit. Commissioner Crowley made a motion to leave all committee and board members the same as last year, but withdrew his motion as it was not seconded. Reappointments for 2014 were made as follows:

\*MOTION\* Commissioner Crowley moved to reappoint Betsy Fitzgerald to sit on the Washington County Council of Government (WCCOG) Board of Directors. Commissioner Cassidy seconded the motion which passed unanimously.

\*MOTION\* Commissioner Crowley moved to reappoint Betsy Fitzgerald to sit on the WCCOG Brownfield Advisory Committee.

Commissioner Cassidy seconded the motion which passed unanimously.

Commissioner Gardner was nominated to be reappointed to sit on the Aroostook / Washington County Workforce Investment Board but the nomination was withdrawn when Commissioner Gardner declined the the nomination. Commissioner Gardner stated that the Board

represents both private and public sectors that plan, oversee and evaluate local workforce development programs. The Committee meets once a month, usually in Aroostook County. Attendance can be done by polycom. After some discussion, it was decided by consensus to elect a board member at the February meeting of the Commissioners.

\*MOTION\* Commissioner Cassidy moved to reappoint Commissioner

Gardner to sit on the Sunrise County Economic Council Board. Commissioner Crowley seconded the motion which

passed unanimously.

\*MOTION\* Commissioner Cassidy moved to reappoint Betsy Fitzgerald

to sit on the DERC&D Board. Commissioner Crowley

seconded the motion which passed unanimously.

It was noted that Commissioner Gardner was reappointed to the Maine County Commissioners Association Board and MCCA Risk Pool Board during the November 2013 Commissioners' meeting.

## AGENDA ITEM: Set overlay percentage amount

Treasurer Jill Holmes stated that the overlay percentage needed to be set. She explained that the overlay is a percentage added to the municipal taxes to compensate for potential unpaid taxes, and the Commissioners may set the rate between .5% and 2%. Jill reported that the overly has been set at .5% for the past two years. She provided the following figures stating that it would be the amount each percent would provide for an overlay; .5% - \$26,247.10; 1% - \$52,494.20; 1.5% - \$78,741.30; 2% - \$104,988.40. Her recommendation was to set the overlay percentage at .5%.

\*MOTION\* Commissioner Cassidy moved to set the overlay percentage

amount at .5%. Commissioner Crowley seconded the motion

which passed unanimously.

AGENDA ITEM: Set County tax interest rate

Treasurer Jill Holmes stated that the county tax interest rate is charged to any taxes that are paid after the due date of November  $1^{\rm st}$ . She stated that the rate has been set at 5% the last several years. Commissioner Crowley recommended continuing with 5% for 2014.
