INSTRUCTIONS TO BIDDERS:

1. The Washington County Commissioners are seeking bids for five (5) **VEHICLES**. Bids must be submitted in an envelope, plainly marked on the outside: **"Police Cruiser Bid, Vehicle # _____"** and shall be addressed to: **Washington County Commissioner's Office, PO Box 297, Machias, Maine 04654, Attn: County Manager Renée Gray** or hand-delivered to the Commissioner's Office at 85 Court Street in Machias. All bids must be received no later than **4:00 P.M., Wednesday, May 6th, 2026**. **A 10% deposit must be included with the bid. Any non-bid awardees will have their deposit mailed back to them. If bidding on more than one vehicle, bids must be in separate individual envelopes, with 10% deposit for each bid. No electronic bids will be accepted.**
2. Bids will be opened at 9:00am on Thursday, May 7th at the office of the Commissioners at 85 Court Street, Machias, ME 04654. Each bidder will be presumed to have familiarized themselves with the particulars of the bid process, and to have read and be thoroughly familiar with the bid documents. The failure or omission of any bidder to receive or examine any form, instrument or document shall in no way relieve any bidder from all obligations in respect to their proposal.
3. Maine State Sales and Use taxes should not be included in any quotation as the County of Washington is exempt from the payment of such taxes. A letter from the State of Maine to this effect is available.
4. The bid shall be based upon vehicles specified and are "as is, where is" condition. The bidder will conduct their own research on the vehicle and will not be permitted to drive the vehicle off the lot. Vehicle may be inspected upon appointment arranged with the County Manager.

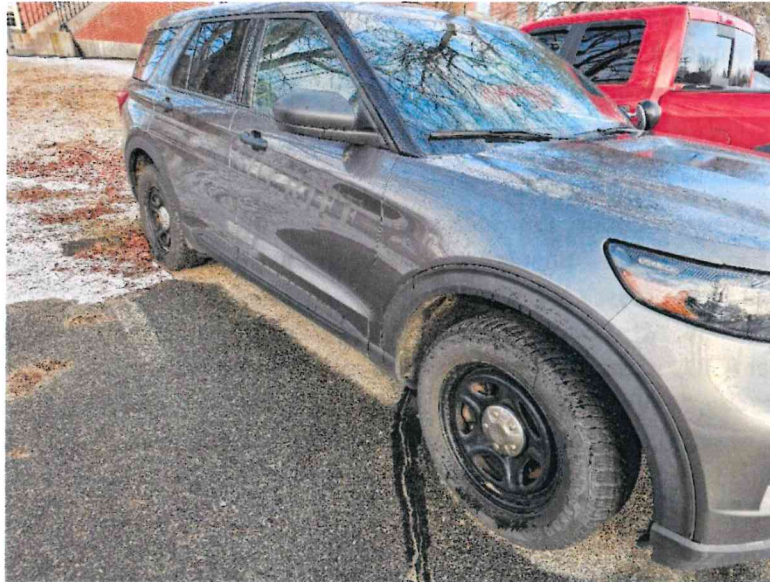
