Commissioner Cassidy called the meeting to order at 4:00 p.m.

County Manager Betsy Fitzgerald introduced Regina Grabrovac of Healthy Acadia to update the Commissioners on the progress of the Community-Corrections Gardening Program, and to discuss the next steps in the garden process. Ms. Grabrovac stated she inspected the County-owned parcel of land with Betsy Fitzgerald, Nate Pennell of the Washington County Soil and Water Conservation District and Mark McBrine, organic farmer and Food Service Manager at Mountain View Corrections Facility in Charleston. Ms. Grabrovac reported that soil tests have been completed. Ms. Grabrovac provided the Commissioners with a map illustrating the best location for the garden, a secondary garden location and a parking area (see attached). Ms. Grabrovac stated Mark McBride recommended using the back side of the site where it is more level. Ms. Grabrovac noted the area recommended by Commissioner Gardner at the last presentation was looked at but is not a big enough area to use. Ms. Grabrovac outlined the next steps. An access road will be needed, and PFAS and heavy metal soil testing is needed to be done. Ms. Grabrovac explained the PFAS and heavy metal soil testing is needed to be sure food grown in this area will be okay for human

consumption. Ms. Grabrovac stated Mark McBrine and State of Maine Commissioner of Corrections Randall Liberty have offered the use of equipment. There is a potential to plow in July. Ms. Grabrovac requested permission from the Board of Commissioners to continue with the soil samples and the next steps outlined in the presentation.

MOTION Commissioner Crowley moved to authorize Healthy Acadia to continue with the next steps for the Community-Corrections Gardening Program as presented.

Dean reported this Broadband initiative may be able to include a portion of the U.T. that would specifically include Trescott Twp. Dean has scheduled a meeting with the project lead, Mark Oullette of Axiom, for the week of June 20th. Dean anticipates he will have more information to provide at the July meeting of the Commissioners.

Dean reported he is working with the State for a reflective sign to be erected on Route 1 for the Edmunds School.

Ms. Hatton presented a request for a Revolving Loan Modification for

Susan Goodrich, dba Sue's Cobscook Bay Café. Ms. Goodrich is requesting a TIF loan in the amount of \$25,000.00. This amount will be added to Ms. Goodrich's TIF loan in the amount of \$80,000.00 that she received in 2020. Ms. Goodrich ran into some unanticipated costs. The requested funds will be used for additional storage, working capital, inventory and equipment. The term of the loan will be 15 years from the original loan date of June 16, 2020. Ms. Hatton noted there is sufficient collateral to cover both the existing loan amount of \$86,259.00 plus the additional amount of \$25,000.00. Ms. Hatton stated the Loan Committee recommended approval of this loan request by a vote of 5-0-0.
